#### 5. City of Keystone Heights Historical Marker Update

Co-Chair Murphy provided a update on the progress of the City of Keystone Heights Historical Marker. The location was approved by City Council in November and the process continues once submitted to Talahassee. Co-Chair Murphy will provide further details when available.

The city council at the time even had to discuss what to do with him. Chair Arnold found a letter from the city council about Andy and wrote a children's story about him and plans to include the story in the goodie bags for the fourth-grade field trip. She also wants to use Andy as the mascot for a public art exhibit featuring fiberglass whooping cranes decorated by local artists.

**Volunteer Opportunities:** The commission is always looking for volunteers to help with their various projects and events.
