The Museum, Welcome Center, and Parking Site Visit Meeting was held at the old Keystone Heights Public Works facility, located at 50 SW Magnolia Ave. The goal is to select a location for building or restoring a building for the Keystone Heights Heritage Commission Museum and Welcome Center.

Mayor Nina Rodenroth presented a PowerPoint (printed) to the group. The information showed the location at 50 SW Magnolia Ave with an option for public parking at 120 SW Flamingo Street (the property is owned by the City of Keystone Heights).

The Magnolia property currently has 2 pole barns, plumbing, and parking. There will need to be recommendations from experts as to the viability of refurbishing the current buildings on the property. Mayor Nina Rodenroth presented information for a portable wooden building and a metal building to be built on site. The next step will be at the next Cty Council Meeting on Nov. 17, 2025, they will consider authorizing the project. Having the staff begin working with the contracted engineers to do a feasibility study on the effectiveness of refurbishing in comparison to buying/new construction.
